## Information about your membership by KidsLife

- KidsLife Wallonie asbl informs you that the minimum duration of a membership is 24 months. Maximum 6 months before the 24th month of affiliation, you may change affiliation (article 72 of the Walloon decree of February 8, 2018);
- KidsLife Wallonie asbl informs you that the decision to change affiliation takes effect from the 1st day of the quarter following that during which the request was sent, unless this request was submitted during the last 15 calendar days of a quarter. In this case, the request will only produce its effects from the 1st day of the second quarter following that of the request ((article 72 of the Walloon decree of February 8, 2018),
- KidsLife Wallonie asbl undertakes not to refuse a request for affiliation from a beneficiary, except in the cases provided for by law, nor to oppose his decision to change organization (article 98 of the Walloon decree of 8 February 2018);
- Affiliation cannot under any circumstances give rise to advantages other than those established by the regulations (article 100 of the Walloon decree of February 8, 2018)..
